RE-ORGANIZATIONAL MEETING

The Board of School Trustees of the Rensselaer Central Schools Corporation met in a Re-Organizational Session on Tuesday, July 5, 2022 at the Rensselaer Central Schools Corporation Administrative Offices Board Conference Room. Board Members present were Janice Deno, Gary Braasch, Charles Parrish, Kevin Armold, Emily Lyons, Rick Odle. Mark Jordan was absent.

President Parrish called the meeting to order at 5:00 p.m.

President Parrish determined a quorum present.

Superintendent Craig administered the Oath of Office to Re-Appointed board member Gary Braasch. (See Attachment "A")

The next item of business was the election of officers for the ensuing year.

Mrs. Deno nominated Mr. Gary Braasch for Board President. Mr. Odle seconded the nomination. Mr. Odle made the motion to close the nominations. Mrs. Deno seconded the motion and the vote of the board was unanimous in favor of the motion. The vote of the board was unanimous in favor of Mr. Braasch as Board President.

Mr. Gary Braasch was elected Board President for the 2022-2023 school year.

Mr. Odle nominated Mr. Kevin Armold for Board Vice President. Ms. Lyons seconded the nomination. Mr. Parrish made the motion to close the nominations. The Pledge of Allegiance was recited by all.

President Braasch stated there were two (2) additions to the agenda. Item Q – Additional Hiring Recommendation and Item L.1 – Summer Projects Update. Mr. Odle made the motion to approve the additions. Mr. Parrish seconded the motion and the vote of the board was unanimous in favor of the motion.

Mr. Parrish made the motion to approve the amended agenda. Ms. Lyons seconded the motion and the vote of the board was unanimous in favor of the motion.

Superintendent Craig recommended Jacob Ahler of Riley and Ahler as Local Attorney and Mike Lacey of Hulse, Lacey, Hardacre and Shine, P.C. as School Attorney for special assignments. Mr. Armold made the motion to approve the recommendation. Mrs. Deno seconded the motion and the vote of the board was unanimous in favor of the motion.

Mr. Odle made the motion to approve the recommendation. Mr. Armold seconded the motion and the vote of the board was unanimous in favor of the motion.

Superintendent Craig requested board approval to pay bills early, before the regular board meetings, due to payment due dates and to avoid penalties. Mr. Odle made the motion to approve the request. Ms. Lyons seconded the motion and the vote of the board was unanimous in favor of the motion.

Superintendent Craig updated the board on the summer projects. Tension cables and fencing has been installed at the tennis courts. The High School roof and pool repairs are on track. There are old restrooms on the north side of the High School that are no longer useful and are being used for storage. The stall dividers and toilets will be removed and shelving installed for storage. The Middle School boilers are in and are ready to be installed. Piping is finished for the High School HVAC. The chiller is still scheduled to arrive in August. The Auditorium air handlers will be installed beginning July 11.

Superintendent Craig requested board approval to set the Corporation Mileage Rate at .48 cents. Mr. Armold made the motion to approve the request. Mr. Odle seconded the motion and the vote of the board was unanimous in favor of the motion.

Superintendent Craig requested board permission to accept resignations and hire personnel as needed prior to the first day of school. Mr. Odle made the motion to approve the request. Mr. Parrish seconded the motion and the vote of the board was unanimous in favor of the motion.
