The Board of School Trustees of the Rensselaer Central Schools Corporation met in Regular Session on Tuesday, May 15, 2018 at the Rensselaer Central Schools Corporation Administrative Offices Board Conference Room. All Board Members were present.

President Parrish called the meeting to order at 7:00 p.m.

President Parrish determined a quorum present.

The Pledge of Allegiance was recited by all.
